The External Provider Program is an integral part of the Environmental Response Training Program (ERTP) in that training courses can be presented to individuals not able to attend courses conducted by the U.S. EPA ERTP training contractors. External Providers can present U.S. EPA ERTP courses that are identical in scope and application that the training contractors provide. The fact that External Providers must meet and accept the requirements set forth by the U.S. EPA to be in the program indicates a high degree of professionalism, quality, and competency.
